Introduction

This document describes the way how recipients can verify the authenticity of a signature in a PDF document.

Documents transmitted by Bank Handlowy w Warszawie S.A. (e.g. bank guarantees) bear qualified signatures.

In order to verify a signature in an electronic document, the recipient should check:

• Identity of the person who signed the document (*should be:* First name and surname, according to the letter of attorney issued by Bank Handlowy w Warszawie S.A.)


• Signature validity, i.e.:

- Status (should be: Signature is VALID)
- Indication of the entity on whose behalf the document is signed (should be: Bank Handlowy w Warszawie S.A.)
- Name of the issuer of the qualified certificate (should be: Krajowa Izba Rozliczeniowa/National Clearing House)



Introduction

In order to verify a signature in a PDF document, open the Signature Panel in Adobe Reader.




